OLD LUMBERYARD SHOOT RENTAL TERMS & CONDITIONS

The following rules apply:

Contract holder must be a member of the Arts Consortium in good standing.

Contract holder must fill out this form and pay reservation fee and security deposit of \$250 before access to Lumberyard is granted.

Reservations are \$30 / per hour, non-refundable and limited to 8-hour maximum.

Photo/Film Shoots are allowed specifically during the time listed on your reservation.

Reservations for photography shoots are subject to change due to special events or unforeseen issues.

General Information: Rental times must include set up and clean up time. Approval of facility applications for groups of persons under the age of 18 will be issued only to adults who accept supervisory and liability responsibilities for the rental contract.

Smoking: No smoking will be allowed on premises.

Alcohol/Drugs: No alcohol or illegal drugs or substances will be allowed on premises.

Guests: Contract holder is responsible for all who are part of the photography / videography shoot, and any and all accidents or injuries to persons or property resulting from use of facilities. Violence, drinking, loud behavior, any illegal activity and unsupervised youth are not permitted. Any violations could result to event cancellation by the Arts Consortium and will result in forfeit of deposit. Facility Staff: Contract holder is required to check-in before the event, be available to Arts Consortium's Staff throughout the duration of the events, and check out with staff and return keys before leaving.

Clean Up: Lumberyard must be returned to the same condition prior to the event.

Security Deposit: \$250 security deposit must be turned in with application.
