PARTICIPATION

Taste The Arts Festival performances will take place during the street festival on **Saturday, October 19, 2024**, from **10am - 5pm** in Downtown Visalia.

The Arts Consortium will provide sound and either a flat dance floor or moderately sized raised stage at **Garden Street Plaza**. The festival takes place outdoors; *please note that there are no private changing areas.*

PUBLICATION

Taste The Arts will be publicized regionally. The Arts Consortium reserves the right to photograph all attendees for the purpose of publicity.

POTENTIAL JURIED ENTRY

If our festival hours cannot accommodate all our applicants, then the Arts Consortium may assign a jury panel to select the festival participants.

GUIDELINES

1. Performances must be family friendly (no adult content)
2. The Visalia Arts Consortium is a 501(c)3 organization, therefore, performances at Taste The Arts must not include poetical or religious content. Performances violating this rule may be asked to leave and/or not be allowed to participate in future Arts Consortium events.
